Santa at the Fairgrounds – The VCHS Child Development Committee will be hosting reindeer at the Valley County arena at the fairgrounds in an open house format. This event replaces the North Pole Express this year and will be held on Saturday, December 9th. The Library will provide letters to Santa and left over sticker sheets from our open house.

New Business

Technology Plan Review – Emily moved and Steve seconded the motion to table the technology plan review until the next meeting. All ayes. Motion carried.

Newsletter Releases Before Christmas – The newsletter is in its final stages of review. The Foundation is including their annual giving letter in the newsletter so it will get into the newspaper during the week of December 13th for the holiday giving season.

November Adult and Children's Events – Kristi reviewed all events with the board. These events include movie matinees; crocheting around the fireplace; Makerspace for the Holidays; Legal Aid; WinterFest fun. Boys STEM class, Buttons and Bingo and a holiday version of Treats with Tresia.

Make Christmas Happen – Due to the current volunteers retiring from the program and there being no one to take their place, Kristi talked it over with staff and they feel they can collectively run the program next year. The Library has already assumed responsibility for the gift giving portion for many years. Everything can be handled at the library and staff will streamline the process. Kristi will talk to Heather Sikyta regarding the legality of the library assuming this role. Emily moved and Deb seconded the motion for the library to start the

process of taking complete responsibility for Make Christmas Happen after getting clearance from legal. All ayes. Motion carried.
